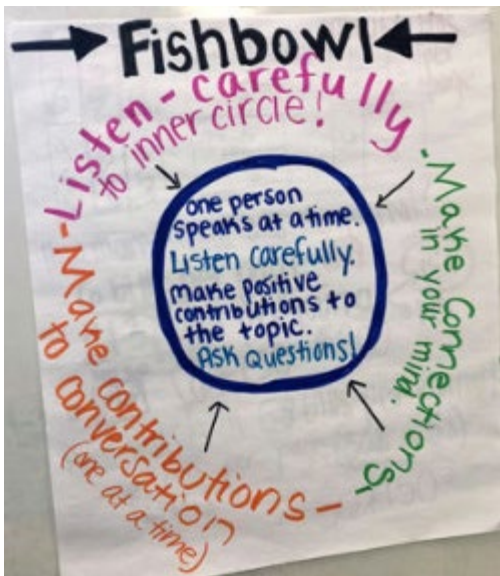
** Join us to demonstrate community interest and support for restorative practices. **

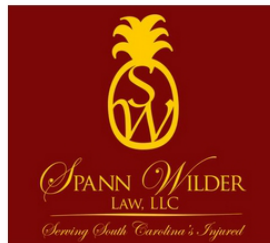
